Updates from Work Group Meetings

The **Care Delivery Work Group** had a meeting on February 3rd. During the meeting, participants discussed design options and provider enrollment processes and standards for the proposed Health Home II program. Effective after-hour access and appropriate case manager to patient ratios were proposed as required standard for Health Home II providers. The **Payment Models Work Group** will be meeting today (2/5/16) from 3:00pm to 4:30pm. The meeting will focus on quantitative goals and capacity building for payment reforms in the District. Ultimately, these goals will serve as recommendations to the Advisory Committee and will inform the SIM State Health Innovation Plan (SHIP). State Health Innovation Plan (SHIP) Process

DHCF and Navigant held the first internal SHIP meeting to discuss draft content for the plan. The **State Health Innovation Plan (SHIP)** is a required deliverable to the Centers for Medicare and Medicaid Services (CMS) as part of the SIM grant. The detailed plan will describe the strategies and methods proposed to transform the structure and performance of the District's entire health system. In the coming weeks, an Interim SHIP will be shared with Work Group and Advisory Committee members during the March 9th Advisory Committee Meeting.

Mayor Bowser Directs \$90 Million to Produce and Preserve 800 Affordable Housing Units

Last week, **Mayor Muriel Bowser announced 12 projects that will provide more than 800 units of affordable housing to approximately 1,760 District residents**. The 12 projects align with the Mayor's commitment to produce, preserve, and protect affordable housing across the city. 83 units will be used as permanent supportive housing units for the homeless, which supports the mayor's goal to end homelessness in the District by 2020. This is a timely investment considering that stable housing for individuals experiencing homelessness can improve health outcomes. For more information about this investment, <u>click here</u>.

Stay Tuned for SIM Stakeholder Engagement Activities. The Department of Health Care Finance and Navigant are beginning to initiate consumer engagement activities. The goal is to perform one hundred interviews and four focus groups by the end of February. The focus of these activities will be to get a better understanding of how District residents utilize the health care system.

The CMS Office of Minority Health recently released a **Guide to Preventing Readmissions among Racially and Ethnically Diverse Medicare Beneficiaries**. The guide is designed to assist hospital leaders and stakeholders focused on quality, safety, and care redesign in identifying root causes and solutions for preventing avoidable readmissions among racially and ethnically diverse Medicare beneficiaries. This is especially important given that racial and ethnic minority populations are more likely than their white counterparts to be readmitted within 30 days of discharge for certain chronic conditions, such as heart failure, heart attack, and pneumonia.
